

Terms Of Use and Legal Terms

WEB SITE USE AGREEMENT

This Internet Web Site Use Agreement (the "Agreement") is between you and The Christian Broadcasting Network, South Africa, Unit 11, 22 Bell Crescent Westlake Business Park, Westlake, Cape Town, 7945, ("CBN SA") with a principal place of business at Use of the CBN SA Internet Web site (the "CBN SA Web Site") signifies your agreement to the terms and conditions of use set forth below in the Agreement:

Acceptance

(1) You acknowledge that you have read the terms and conditions of use and that you accept the terms thereof. YOU AGREE TO READ THESE TERMS AND CONDITIONS OF USE CAREFULLY BEFORE USING THIS CBN SA WEB SITE. Use of Information; Privacy Policy

Use of Web Site; Non-Commercial Use

(b) Identification of the copyrighted work claimed to have been infringed, or, if multiple copyrighted works at a single online site are covered by a single notification, a representative list of such works at that site;

(e) A statement that you have a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law; and

(f) A statement that the information in the notification is accurate, and under penalty of perjury, that you are authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.
